# \$50 Family registration fee and First week's fees to be paid one first day of enrollment. \*\*We will NOT take children without registration and weekly commitment.

<u>Part Time daytime care</u> means that your child will be attending 5 half days or 3 full time days per week. Part time positions will be suspended if enrollment is at capacity in that particular class/age group and may **not** always be available.

<u>Night Care part time</u> is the purchase of individual nights. Attendees at Wee Care too may purchase individual days. Part time slots are available if enrollment is NOT at capacity in that particular class/age group and may not always be available.

<u>All Payments are due on Friday in advance of the next week.</u> Arrangements can be made to pay bi-weekly or monthly but still must be in advance in order to avoid late fees. See management to make arrangements.

<u>Payments made after Monday will be charged a late fee of \$10.</u> A late fee of \$10 will be added automatically every Tuesday when no payment is made. Payments must be made in advance in order to prevent this fee from posting.

#### If no payment is made for two weeks, childcare will be suspended.

**If your child purposefully damages** or breaks any property of Wee Care or its other customers, the parent is responsible to replace or repair it.

<u>Fees listed above are charged regardless of absenteeism for the time that you are enrolled.</u> We do **NOT** charge a daily rate, or deduct for absences or unauthorized vacation weeks. **ALL customers pay based of an agreed upon weekly amount.** 

We allow for one week vacation per year with no charge after a year of attendance. The child cannot attend in order to receive this week at no charge. The vacation week needs to be authorized in writing two weeks before the vacation is taken. This week has no cash value and customer's account must be current in order to redeem this week.

**In the event you are leaving the daycare**, you must give two weeks' notice in writing to the date of your departure. This includes the summer. If no notice is given, then a charge equivalent to two weeks of service will be added to your closing bill. ELCNF parents must be paid in full with us in order to receive funding at their next childcare center.

#### There is a \$35 return check fee.

All accounts that hold balances beyond 90 days will be turned over to a collection agency. The customer is responsible for all fees associated with the collection agency, attorney's fees, court costs, etc. Any/all of the afore mentioned fees will be added to the final bill in addition to 1.5% interest added monthly until the balance is paid. If the customer leaves without two week notice, an additional two weeks of fees will be added to the final bill.

### <u>Early Learning Coalition parents are responsible for their registration fee and parent fees.</u>

- Parents are responsible for the cost of any absences beyond the three excused absences they are allowed. These absences will be tallied according to the Early Learning Coalition's reimbursement rate and added to the parent's bill.
- Most of our fees are slightly more than the ELC's reimbursement rates are. Parent fees will be in addition to any amounts that the Early Learning Coalition does not reimburse.
