**FIRST AID:** In case of eye contact, flush immediately with plenty of water for at least 15 minutes and seek medical attention if problems persist. For skin, wash thoroughly with soap and water. If affected by inhalation of vapor or spray mist, remove to fresh air. If swallowed, do not induce vomiting. Drink large quantities of water or milk and seek medical attention.

### DIRECTIONS FOR USE:

BMRT-3 is designed to replace ordinary floor cleaners and caustic degreasers in a variety of food service industries where waste oils or grease are present. May be used as a floor cleaner in industrial kitchens. Microbes are USDA certified.

**FLOORS:** Add 3-4 oz of BMRT-3 to each gallon of warm or cold water. Increase slightly for heavier cleaning, decrease for lighter soiled areas. Rinse with potable water in food preparation areas.

**HEAVY SOIL:** For heavy greasy deposits, add up to 8 oz per gallon to a mop bucket (4-5 gal). Spray or deck brush, rinse or squeegee.

**APPLICATION:** Slop mop, let stand for 5-10 minutes, deck brush or mop to aid cleaning, then rinse, dry mop or squeegee as necessary to remove excess liquid. BMRT-3 will work equally well in a foam gun, pressure washer or floor machine.
