Other Information

- If the instrument is lost, stolen, or destroyed, the renter is responsible for the full retail price of the instrument.
- ALL REPAIRS AND ADJUSTMENTS MUST BE MADE BY CLASSICAL STRINGS. Repairs made necessary by ordinary wear and tear will be made at no cost to the renter, assuming rental payments have been made on time and are current. Accessory repairs -- strings, rosin replacement, case straps/handles -- are not covered under the terms of this agreement. Repairs made necessary by damages beyond the normal wear and tear will be repaired by Classical Strings, at the expense of the renter.
- Exchanges to the next instrument size will be made free of charge assuming rental payments have been made on time and are current, and the previous instrument is returned in good condition, allowing for normal wear and tear.
- If rent is delinquent by 2 weeks and arrangements have not been previously made, the credit card on file will be charged the rental amount plus a processing fee (approximately 3.4%).
- Rental fees are due each month on the 5th, 15th or 25th of the month, whichever date precedes and is closest to the date of this contract. Rental fees may be paid in advance (i.e., quarterly or annually).
- If rent is paid on time **and is current**, 75% of the rental fees may be applied to the retail purchase of the instrument. Sales tax will be added to purchase price and 9% annual interest will be charged. If purchase is made within three (3) months of the original rental contract date, 100% of the rental fees will be applied toward the purchase price.

The undersigned hereby declares and represents that they have read the foregoing agreement, that all statements made therein are complete and true to the best of their knowledge.

This insurance will NOT cover the cost of replacing broken strings, broken bridges, bow rehairs, theft without a police report, or obvious neglect.

The cost of this insurance is nonrefundable and will not go toward the purchase price of the instrument.
