### PROTECT YOUR INVESTMENT

A healthy roof consists of many parts. With the Owens Corning Preferred Protection Limited Warranty,\* every component—not just the shingles—of your Owens Corning Roofing System is covered by an extended warranty. It's a smart way to ensure your investment is protected for years to come.

### MAXIMIZE YOUR COVERAGE

Increase the non-prorated coverage—Standard warranties have a very limited non-prorated period where there is 100% coverage for both material defects and the labor to repair or replace them. This usually occurs in the first few years after installation. The Preferred Protection Limited Warranty provides a significantly extended non-prorated period—of up to 50 years in some cases (see chart below). *You get full coverage for a much longer time period.*

### THE PERFORMANCE OF A ROOFING SYSTEM

All Owens Corning system components are covered—Since several Owens Corning Roofing System components are required for the Preferred Protection warranty coverage, individual components take on the warranty of the shingles installed on the field of the roof. In many cases, this extends their warranty. *Rest easy knowing your entire Roofing System is covered (see opposite page for requirements).*

### PROTECTION FROM WIND

Up to 15 years of extended wind resistance—After sealing and with proper installation, if your shingles are blown off or damaged by wind, we will reimburse you for the reasonable cost of replacing them. *You'll be protected from winds up to 130 MPH—depending on the shingle you install (see chart below).*

### TRANSFER IN FULL

One-time transfer—You can transfer this warranty once anytime during the life of the warranty. With no reduced transfer coverage, the Preferred Protection Limited Warranty is highly desirable to future home buyers. *It's a good investment if you're planning to sell.*

## STANDARD LIMITED WARRANTY ON SHINGLES VS. PREFERRED PROTECTION LIMITED WARRANTY

When making an important investment to your home, like installing a new roof, you should understand the warranty protection that comes with it.

### STANDARD LIMITED WARRANTY ON SHINGLES

1. Coverage on shingles is automatic upon installation; coverage is not affected by the installation of other Owens Corning roofing components like vents, underlayment or Hip & Ridge shingles, nor are the components covered under this warranty. They have separate warranties.
2. Warranty covers any manufacturing defects that affect the performance of the shingle.
3. During the up-front non-prorated period (called Tru PROtection®) of the standard warranty, the defective shingles will be repaired or replaced, including labor, at the cost of Owens Corning.
4. After the non-prorated period has elapsed (5 or 10 years; see chart inside), the amount of the cost paid by Owens Corning will be prorated based on the number of months that have passed in the entire warranty period. That is, the cost covered by the warranty is reduced according to the following formula:

5. Labor for repairing or replacing defective shingles is not covered once the non-prorated period has elapsed.
6. Warranty is transferable one time, anytime during the life of the warranty.

### PREFERRED PROTECTION LIMITED WARRANTY

1. To qualify for this warranty, you must install Owens Corning shingles, any breather-type No. 15 or 30 asphalt-saturated felt underlayment and three of these five products: a) Owens Corning Hip & Ridge shingles; b) VentSure ventilation products; c) Owens Corning Starter Shingle products; d) WeatherLock Self-Sealing Ice & Water Barrier products, or e) Owens Corning Fiberglas Reinforced Felt (which qualifies as the mandatory breather-type No. 15 or 30 breather-type felt underlayment listed above).
2. All Owens Corning Roofing System components installed (listed above) take on the warranty of the shingles installed on the field of the roof. Any Roofing System component, including shingles, that proves to be defective during the non-prorated warranty period will be repaired or replaced, including labor, at the cost of Owens Corning.
3. Although the Preferred Protection Limited Warranty is prorated, the non-prorated period has been significantly extended beyond that of the standard shingle warranty. The Preferred Protection non-prorated period is increased to 15 to 50 years (see chart inside). After the non-prorated period expires, normal proration applies (see formula at left).
4. You must complete and send in a registration card along with a warranty fee. Depending on the size of your roof, this fee will change—ask your Preferred Contractor for details.
5. Warranty is transferable one time, anytime during the life of the warranty.

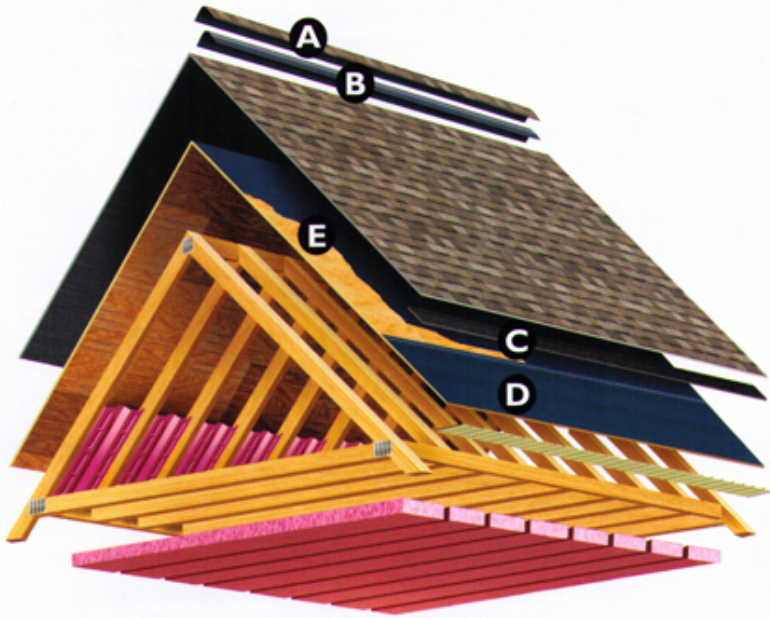

## ROOFING SYSTEM PRODUCTS AND REQUIREMENTS

In addition to Owens Corning shingles and any breather-type No. 15 or No. 30 asphalt-saturated felt underlayment, you must purchase three of the five products listed below to qualify for the Preferred Protection Limited Warranty.

- A** Owens Corning Hip & Ridge shingles
- B** VentSure® ventilation products
- C** Owens Corning Starter Shingle products
- D** WeatherLock® Self-Sealing Ice & Water Barrier products

If you live within the shaded area indicated below, WeatherLock® Self-Sealing Ice & Water Barrier products are required with your purchase of Owens Corning Hip & Ridge shingles, VentSure® ventilation products, Owens Corning Starter Shingle products **OR** Owens Corning Fiberglas™ Reinforced Felt Underlayment. In those states where Owens Corning has made WeatherLock Ice & Water Barrier products optional (see unshaded areas below), local building codes may still require a waterproofing ice and water barrier. In this case, WeatherLock Ice & Water Barrier products will become a required system component for this warranty.



- E** Owens Corning Fiberglas™ Reinforced Felt Underlayment (qualifies as the mandatory breather-type No. 15 or No. 30 asphalt-saturated felt underlayment, as listed above)

**Note:**

The Owens Corning Roofing System must be installed over a clean roofing deck and not over existing shingles or other roofing materials to be eligible for this Preferred Protection Limited Warranty.
